SCS Principal Report Nov 2021

We are currently into another year filled of uncertainty due to COVID restrictions. The plan at the beginning of this year is to slowly integrate back to a more "normal" school environment.

Highlights for the year so far:

- Majority of families returned to face-to-face instruction in the fall.
- High school students have lockers once again and can move from class to class unlike last year where they were designated to one room.
- All breakfast, lunch and servery/food programs still are not in service. (Prepackaged food sales could happen ex) sub sales etc.)
- Vending machines are operational. Still not permitted to have microwaves unless for PAA programs.
- Education Week was cancelled again this year with the potential of having a book fair in the spring.
- Fundraisers: SRC Supper in the Field; Mom's Pantry (one in fall; one in spring). SRC will look after the cost of putting a load pea gravel under play structure and will add a cement pad for our Gr 7-12 students-basketball etc. located near the East entrance.
- Grad Plan: (Fri June 24th Outdoors)
- Extra-curricular activities have returned with some restriction. We have made it through cross country and volleyball seasons highlighted by Jailin Soltys reaching provincials in cross country; Junior Boys vball team finished 4th place finish at Districts; and the senior boys finished 4th place at Provincials. Basketball is now starting at the school with Badminton, archery, and track and field to follow. We have a SRC for grade 11-12's, Pottery, SADD, Band, and Yearbook groups for kids at the school as well. They operate under COVID guidelines so modified a bit from past years.
- At this point all visitors, staff and students are required to wear masks in schools. All staff (including substitutes) must show proof of vaccination or a weekly negative test.
- We have had our first school assembly in the gym for Remembrance Day. It was great to be able to get together for the first time in over a year!
